DOCUMENTATION:

Effective December 1, 2022, the State Controller's Office (SCO) will issue earning ID GHCP as supplemental payments for BU 08 through an automated payment process if the eligible employee is currently an active full-time and part-time employee. Earning ID GHCP payments will issue in the first payroll cycle following the eligible month. Example, December 2022 pay period payments will issue in the payroll cycle dated January 4, 2023. Departments should key payment via PIP for any other eligible BU 08 employee that does not meet the automated payment criteria. If unable to key via PIP submit STD. 674 to SCO for payment processing.
