Effective January 1, 2023, all employees receiving a salary rate below the new minimum salary rate for each range and/or step shall move to the new minimum salary rate for each range and/or step, including employees who separated from state service prior to January 1, 2023, and have lump sum payments that extend beyond January 1, 2023. Employees already above the new minimum are not entitled to an increase.

DOCUMENTATION:

Departments will be responsible for keying the SAL transactions effective January 1, 2023 for eligible employees in class codes listed above to increase their salary range and/or step. For employees who separated from state service prior to January 1, 2023 and have lump sum payments that extend beyond January 1, 2023, departments shall adjust their lump sum to reflect the above salary changes.
